MEETING OPEN TO THE PUBLIC

Council President Tighe opened the floor to the public for discussion on any topic.

Judge Daryl Todd – 221 Berkshire Avenue, Linwood

Judge Todd thanked the Mayor for his appointment back on to the Linwood Board of Education.

Seeing and hearing no other members from the public wishing to be heard, Council President Tighe closed the floor.

FINAL REMARKS BY MAYOR AND COUNCIL

Mayor DePamphilis – The Mayor congratulated the Public Works Department on their hard work. He announced that two of the Linwood Board of Education members, Diana Rutala and Joe Jacobs have requested not to be reappointed at the end of their terms this April. They have both done an outstanding job on the Board. The Mayor has reappointed Donna Michael-Ziereis. He has also appointed former Judge Daryl Todd, who used to be a member of the Board prior to becoming a Superior Court Judge. The Mayor credits Judge Todd with the success of the Linwood schools and for maintaining a quality education. The Mayor has also appointed Michelle DeMorat. Mrs. DeMorat is the co-president of the Linwood Education Foundation and will be a great addition to the Board. The Mayor reported that Police Chief Colin Hickey will retire on February 28, 2015. Captain Doug Carman will automatically become Acting Chief and Lieutenant John Hamilton will become Acting Captain. The Mayor has appointed Sergeant Jason Weber to become Acting Lieutenant at that time, who will also continue to operate the Detective Bureau.

<u>Councilman Paolone</u> – Councilman Paolone echoes some of the comments of the Mayor. He is excited that Donna Michael-Ziereis is being reappointed to the Linwood Board of Education and welcomes the new appointments. Linwood is lucky to have so many intelligent and talented volunteers. Councilman Paolone congratulated Sergeant Weber and the Public Works Department.

<u>Councilman Beinfest</u> – Councilman Beinfest served on the Board of School Estimates when Judge Todd was on the school board. It was great working with him and he is happy to know that the board will once again benefit from his talents. Councilman Beinfest believes there is a great team to run the Police Department. They are thoughtful and work well together. He also congratulated the Public Works Department. They have accomplished a great achievement.

<u>Councilwoman DeDomenicis</u> – Councilwoman DeDomenicis believes it's nice to honor and recognize employees on their successes. She thanked and commended the members of the Public Works Department. She also announced that refreshments will be served after the meeting.

<u>Councilman Gordon</u> – Councilman Gordon wished the Police Department employees luck as they transition into their new roles. He believes it is a great group of individuals. Councilman Gordon also congratulated the Public Works Department on their achievement on the recent job they did with the storm. He welcomed Judge Todd and Mrs. DeMorat to the Board of Education and welcomed back Donna Michael-Ziereis. Councilman Gordon also advised of upcoming work in March along Route 9. The DOT will be installing a rumble strip.

<u>Councilman Matik</u> – Councilman Matik advised that he feels lucky when he spends time in other towns and sees the differences in Linwood. Linwood has very talented volunteers that fill positions where other towns pay for professionals. He welcomed Judge Todd and Mrs. DeMorat to the Board and congratulated Donna Michael-Ziereis on her reappointment. Councilman Matik congratulated the Public Works Department.

<u>Councilman Heun</u> – Councilman Heun thanked the members of the Police Department for their efforts and congratulated them on their new positons. He welcomed Judge Todd back onto the school board. Welcomed Mrs. DeMorat and congratulated Mrs. Michael-Ziereis on her reappointment. They are all top notch individuals and will do a great job. Councilman Heun congratulated the Public Works Department. They do their jobs well and they do it correctly.

<u>Council President Tighe</u> – Council President Tighe congratulated the Public Works Department and noted that by working 1000 days without a loss time accident saves the taxpayers money in workers compensation. He welcomed Judge Todd, Mrs. DeMorat, and welcomed back Mrs. Michael-Ziereis to the Board of Education. Council President Tighe addressed the members present from the Police Department, noting that it is good to have them at the meeting. He can feel their energy and their enthusiasm is showing. Council President Tighe thanked Councilman Heun, Mr. Youngblood, and Mr. Polistina for their efforts negotiating the redevelopment projects.
