FINAL REMARKS BY MAYOR AND COUNCIL

Mayor DePamphilis – The Mayor congratulated Alyssa Aldridge.

<u>Councilman Heun</u> – Councilman Heun thanked Councilman Matik and his committee for their work on the budget. He also thanked the employees of the City for their help keeping the costs down.

<u>Councilman Ford</u> – Councilman Ford also commended Councilman Matik and his committee for their efforts on the budget.

<u>Councilman Gordon</u> – Councilman Gordon understands that it has been a hard couple of years and it is no small feat putting together a budget that works. He thanked and commended Councilman Matik and the Budget Committee. They did a great job keeping the services that the community expects and demands. It is a responsible budget.

<u>Council President Paolone</u> – Council President Paolone worked on the budget committee in the past and understands how difficult it is. He thanked Councilman Matik and his committee for their efforts. He knows residents will be disappointed with taxes going up 2 cents but the City's portion of overall the overall tax bill is small. The overall increase could be 9.9 cents. He discussed the City's shared services and the savings involved. He discussed the job done by Department Heads and Councilman Matik on holding the line and keeping costs down. Council President Paolone discussed a letter by the County Executive recently sent to Governor Murphy requesting the Governor to honor the 13% as requested in the PILOT program. He feels if honored, it would help the City. He discussed the decline in ratables in Atlantic City and the new Hard Rock Casino. The Revel may even possibly open again. They will all help Linwood's property values. Senator Brown and County Executive Levinson do a great job and will continue to work for improvements.
