Council President Tighe asked if any member of Council would like to remove any items from consent. Councilman Gordon motioned, seconded by Councilman Beinfest, to approve Resolutions No. 95-96, 98-100, 102-103 of 2014. All members of Council were in favor. Motion was approved.

MEETING OPEN TO THE PUBLIC

Council President Tighe opened the floor to the public for discussion on any topic.

Seeing and hearing no members from the public wishing to be heard, Council President Tighe closed the floor.

FINAL REMARKS BY MAYOR AND COUNCIL

<u>Mayor DePamphilis</u> – the Mayor congratulated Mrs. Desch. He remarked on the success of the Memorial Day Parade, which included a first annual one mile run. One hundred and sixty-six people participated in the run. The Recreation Board did a great job as did the Police, Fire, and Public Works Departments.

<u>Councilman Beinfest</u> – Councilman Beinfest thanked Laurie Montgomery for her efforts with the parade. This was her first event as the new Park Director. Councilman Beinfest discussed the renovations to the shed behind the Historical Society building and encouraged everyone to visit. It was been decorated to reflect the three prior uses of the building; the City's first Police Department, a store, and a gas station.

<u>Councilwoman DeDomenicis</u> – Councilwoman DeDomenicis also commented on the success of the Memorial Day Parade.

<u>Councilman Gordon</u> – Councilman Gordon echoed the Mayor's comments regarding the Memorial Day Parade. He also thanked Public Works for doing a great job getting the park ready for the event.

<u>Councilman Paolone</u> – Councilman Paolone discussed the retirement of employees after twenty-five years, noting how nice it is to see they still care about their jobs as Mrs. Desch does. He also noted the Resolution accepting Chief James's resignation. Councilman Paolone discussed the Resolution supporting Assembly Bill A-1021 and Senate Bill S-268 requiring direct payment of energy taxes to municipal government. He urged everyone to reach out to their legislators to support this issue.

<u>Councilman Matik</u> – Councilman Matik thanked Chief James for his efforts. As Chairman of Public Safety, Councilman Matik worked closely with the Chief. He indicated that the Chief made his job easier. Councilman Matik also discussed his support for the bill requiring the payment of energy taxes to municipalities.

<u>Councilman Heun</u> – Councilman Heun commended Assemblyman Brown for his efforts to return the energy taxes to municipalities. He commended the efforts of Laurie Montgomery and everyone involved in the success of the Memorial Day parade.

<u>Council President Tighe</u> – Council President Tighe echoed the comments of the Mayor and Council on the Memorial Day Parade. He congratulated Laurie Montgomery and the Recreation Board on their efforts. Council President Tighe also discussed his support of the energy tax receipt bill.

Council continued their discussion on the capital budget from the Caucus session. Discussion ensued upon the street paving project as it relates to the South Jersey Gas project. Council also discussed the purchase of a street sweeper and the benefits of same. It was determined the City would seek quotes to contract out for landscaping and janitorial services of City properties. Once those costs are obtained, Council will evaluate same.
