CALL TO ORDER

Council President Ralph Paolone called the meeting to order at 6:32 P.M., noting that the meeting had been advertised in compliance with the requirements of the Open Public Meetings Act.

Council President Paolone asked if any member of Council would like to remove any other items from consent. No items were removed. Councilwoman Byrnes motioned, seconded by Councilwoman DeDomenicis, to approve Resolutions No. 127-137 of 2022. All members of Council were in favor. Motion was approved.

APPROVAL OF BILL LIST: \$1,574,724.56

Councilwoman Byrnes motioned, seconded by Councilwoman DeDomenicis, to approve the bills for payment. A roll call vote was heard with six in the affirmative, and one abstention by Councilwoman Albright. Motion was approved. (The bill list is attached as Exhibit A)

MEETING OPEN TO THE PUBLIC

Council President Paolone opened the floor to the public for discussion on any topic.

<u>Kathleen Spaeth 108 Country Club Drive, Linwood</u> – Mrs. Spaeth discussed a night when she called the police two times because she felt the music from Linwood Country Club was significantly audible. The police responded each time. No violations were issued. She felt a violation was necessary. She wrote to the Chief of Police regarding the situation and does not agree with his response. She also indicated that she was invited by the owners of the Country Club to have a free meal at one of their restaurants on the night the music was playing. She declined the invitation. She also questioned why the Country Club did not have to pay a fine the last time violations were issued. Council President Paolone advised that the Ordinance includes a provision that if a remedy is put in place, no fine is issued for a first offense. He had hoped that the Country Club would purchase a sound limiter. He suggested that another meeting with the Country Club may be necessary.

Seeing and hearing no other members from the public wishing to be heard, Council President Paolone closed the floor.

FINAL REMARKS BY MAYOR AND COUNCIL

Mayor Matik – The Mayor advised that he and the Chief attended a meeting regarding the progress of the Central Municipal Court. There have been some issues and they are working to correct them. He also announced that today bids were accepted for the resurfacing of Franklin Boulevard. The project will include a bike lane. With the projected 20% to 30% increase in the state health benefits plan, the City will shop around for better pricing to keep taxes down.

Councilwoman DeDomenicis - Councilwoman DeDomenicis indicated National Night Out was a huge success.

<u>Councilwoman Byrnes</u> – Councilwoman Byrnes agreed that National Night Out was great. She thanked everyone for their efforts. Tuesday, August 16 at 6pm is the Mayor Vass building dedication at the Library. All the improvements to the Library look great. She thanked Jen Heller for her efforts.

<u>Councilman Michael</u> – Councilman Michael agrees that National Night Out was very impressive. Everyone did a great job. He thanked all involved.

<u>Councilman Levinson</u> – Councilman Levinson also indicated how great National Night Out was. His family had a great time. He commended everyone for their efforts.

<u>Councilman Ford</u> – Councilman Ford congratulated the Eagle Scouts and commended their dedication and volunteerism.

FINAL REMARKS BY MAYOR AND COUNCIL (continued)

<u>Councilwoman Albright</u> – Councilwoman Albright congratulated the Eagle Scouts and is looking forward to the new Eagle Scout project. She is discouraged that the Country Club is still booking bands for outside. She thought it was only going to be acoustic music. She looks forward to discussions with them.

With no further business to be addressed by Council, Councilman Levinson motioned, seconded by Councilman Ford, to adjourn at 7:000 P.M.
