## 4. Councilwoman Byrnes

- A. Neighborhood Services
  - 1. Councilwoman Byrnes advised of a Resolution on the agenda recognizing October 6, 2021 as Knock Out Opioid Abuse Day. This is the second year the City has recognized the day.
  - 2. Councilwoman Byrnes reviewed a Resolution authorizing an Agreement with Atlantic County for the Alliance Grant.

#### 5. Councilwoman DeDomenicis

- A. Public Works
  - 1. Councilwoman DeDomenicis advised of an honorary Resolution on the agenda for Tony Hare for twenty-six years of employment with the City.

#### 6. Councilman Ford

- A. Planning, Engineering, & Development
  - 1. Councilman Ford discussed an Ordinance on the agenda amending Chapter 277, Zoning, Prohibited Uses to clean up some language.

  - 1. Councilman Gordon discussed a Resolution on the agenda awarding a Contract to American Pipe Cleaning for the 2021 Video Inspection & Main Cleaning, Contract No. 34. This is the second phase of this project. The first phase was 64,000 feet. This phase will include 70,000 feet. When the project is completed the information will be in a GIS format and the Engineer will give a presentation on the project.
  - 2. Councilman Gordon advised of a Resolution supporting Application for the NJDOT Safe Routes to School Program. This is to interconnect sidewalks in and around Belhaven School.
