## MEETING OPEN TO THE PUBLIC

Councilwoman Byrnes opened the floor to the public for discussion on any topic.

<u>Jack Verseput, 306 Poplar Avenue, Linwood</u> – Mr. Verseput asked City Council to do something with the five-way intersection near his house discussing how very dangerous it is. He indicated that people are speeding and not stopping for the stop signs. He suggested they realign the intersection similar to what Margate did.

<u>Kathleen Spaeth, 108 Country Club Drive, Linwood</u> – Mrs. Spaeth discussed an audible event at the Linwood Country Club this past weekend. A citation was issued. She is concerned this will continue.

Seeing and hearing no other members from the public wishing to be heard, Councilwoman Byrnes closed the floor.

#### FINAL REMARKS BY MAYOR AND COUNCIL

<u>Mayor Matik</u> – The Mayor reported on the Atlantic County Central Municipal Court. They are currently in the hiring process and moving forward to begin on January 1, 2022. This will save the City considerable money. He invited everyone to check out the improvements to the Library. He also asked the Engineer to take a look at the intersection Mr. Verseput was discussing. The Mayor's vehicle was hit there in the past and he was almost just hit again.

<u>Councilman Michael</u> – Councilman Michael thanked everyone for attending the meeting. He advised Mr. Verseput that he will talk to the Chief about the intersection to see what they can do in the mean time to mitigate the problems. He thanked Mrs. Spaeth for taking the time to call about the Country Club. He understands that she was the only call that night. However, he was told by other residents that they could hear the music as well. The Country Club will have to take steps to work within the Ordinance.

<u>Councilman Ford</u> – Councilman Ford thanked everyone for attending the meeting. He will look at the intersection in Margate that Mr. Verseput is referring to.

<u>Councilwoman DeDomenicis</u> – Councilwoman DeDomenicis announced that today is the first day of Fall. She reminded everyone that the Farmers Market is ongoing every Saturday at Central Square.

<u>Councilwoman Byrnes</u> – Councilwoman Byrnes announced that the Recreation Board is planning an Octoberfest for October 22, 23, and 24. More information will be provided soon. She thanks Mr. Verseput for his comments. She also thanked Chip Jones, Public Works Supervisor, for all his help preparing the grounds at the Library for Mayor Gaffney's daughter's book signing. She understands Mr. Jones is a long-time friend of the family and noted how everything looked beautiful.
