

**LINWOOD COMMON COUNCIL  
MINUTES OF REGULAR MEETING  
October 11, 2017**

**FLAG SALUTE:**

Councilwoman Stacy DeDomenicis led the flag salute.

**CALL TO ORDER**

Council President Ralph Paolone called the meeting to order at 6:11 P.M., noting that the meeting had been advertised in compliance with the requirements of the Open Public Meetings Act.

**ROLL CALL**

**APPROVAL OF MINUTES WITHOUT FORMAL READING**

Councilwoman DeDomenicis motioned, seconded by Councilman Ford, to approve the minutes of the September 27, 2017 Regular meeting without formal reading. All members of Council were in favor with one abstention from Councilman Heun. Motion was approved.

**ORDINANCES**

**9 OF 2017** AN ORDINANCE AMENDING CHAPTER 119 CONSTRUCTION CODES, UNIFORM, SECTION 119-3 FEES OF THE CODE OF THE CITY OF LINWOOD AND REPEALING ALL ORDINANCES HERETOFORE ADOPTED, THE PROVISIONS OF WHICH ARE INCONSISTENT HEREWITH.

The Clerk read Ordinance No. 9 of 2017 by title only. Councilman Heun motioned, seconded by Councilman Gordon to approve Ordinance No. 9 for first reading. A roll call vote was heard with seven in the affirmative. Motion was approved.

**10 OF 2017** AN ORDINANCE SUPPLEMENTING AND AMENDING CHAPTER 251 OF THE CODE OF THE CITY OF LINWOOD, TAXATION, ADDING ARTICLE III "100% DISABLED VETERANS PROPERTY TAX REFUNDS; AND REPEALING ALL ORDINANCES HERETOFORE ADOPTED THE PROVISIONS OF WHICH ARE INCONSISTENT HEREWITH.

The Clerk read Ordinance No. 10 of 2017 by title only. Councilman Ford motioned, seconded by Councilman Matik to approve Ordinance No. 10 for final reading. Council President Paolone opened the floor for discussion on Ordinance No. 10. Seeing and hearing no members of the public wishing to be heard, Council President Paolone closed the floor. A roll call vote was heard with seven in the affirmative. Motion was approved.

**RESOLUTIONS WITHIN CONSENT AGENDA**

**167-2017** A Resolution accepting the resignation of Kacey Johnson

Council President Paolone asked if any member of Council would like to remove any items from consent. No items were removed. Councilwoman DeDomenicis motioned, seconded by Councilman Gordon, to approve Resolution No. 167 of 2017. All members of Council were in favor. Motion was approved.

**APPROVAL OF BILL LIST: \$324,906.69**

Councilwoman DeDomenicis motioned, seconded by Councilman Beinfest, to approve the bills for payment. A roll call vote was heard with seven in the affirmative. Motion was approved. (The bill list is attached as Exhibit A)
