

**LINWOOD COMMON COUNCIL**  
**CAUCUS MINUTES**  
**November 14, 2018**

Council President Paolone called the meeting to order at 6:01 P.M., noting that the meeting had been advertised in compliance with the requirements of the Open Public Meetings Act.

1. Roll Call

2. Approval of Minutes Without Formal Reading

A. Public Works
