MEETING OPEN TO THE PUBLIC

Council President Paolone opened the floor to the public for discussion on any topic.

Steve Zambetoglou 726 Brighton Drive, Linwood

Mr. Zambetoglou indicated that he spoke to City Council over a year ago requesting a guard rail on Route 9 behind his home. He witnessed a child on a bicycle almost get hit by a car while riding on the sidewalk. He is hoping one can be installed soon.

Seeing and hearing no other members from the public wishing to be heard, Council President Paolone closed the floor.

FINAL REMARKS BY MAYOR AND COUNCIL

<u>Mayor DePamphilis</u> – Mayor DePamphilis attended the annual tree lighting at the Arboretum and noted how well attended it was and commended all involved for their efforts.

<u>Councilman Heun</u> – Councilman Heun echoed the Mayor's comments on the tree lighting. The event gets better every year.

<u>Councilman Matik</u> – Councilman Matik also attended the tree lighting and commended the efforts of the Recreation Board and Laurie Montgomery. He advised Mr. Zambetoglou that since Route 9 is a state road, the state Department of Transportation would have to authorize and install the guardrail. City Council has written to them in the past requesting same. He will follow up with them.

<u>Councilman Ford</u> – Councilman Ford also advised Mr. Zambetoglou that he will follow up with the state on the guardrail. He commended the efforts of the Recreation Board on a successful tree lighting event. He announced the retirements of Joe Breidenstine and Lynn Roesch noting that they will both be missed. Mr. Breidenstine started his public service in 1978 and will retire on December 31, 2019. If you see him around the City, thank him. He dedicated a lot of time working for our community.

<u>Councilman Gordon</u> – Councilman Gordon echoed everyone's comments on the tree lighting. A great job to all involved. He worked with Mrs. Roesch when he was on the Zoning Board. She was always very dedicated and professional. She imparted a lot of knowledge to the members on the Board. She will be missed. Mr. Breidenstine has worked for our community for over 40 years which is highly commendable. He too will be missed.

<u>Councilwoman Byrnes</u> – Councilwoman Byrnes advised that a new outside Menorah will be lit for Hanukkah. She wished everyone Happy Holidays.

<u>Councilwoman DeDomenicis</u> – Councilwoman DeDomenicis commended everyone for a successful tree lighting. She wished everyone a Merry Christmas and a Happy Hanukkah.

<u>Councilman Matik</u> – Councilman Matik advised that the sirens that everyone is hearing are Santa going around on the fire truck.

<u>Council President Paolone</u> – Council President Paolone thanked Mrs. Roesch. He also worked with her on the Zoning Board. She was very professional and did a tremendous job. Mr. Breidenstine's service record is impeccable. He will miss them both. Council President Paolone indicated that under tonight's Consent Agenda was a Resolution to authorize an Agreement for Shared Municipal Court Services with Northfield. He thanked Mayor Chau for attending the meeting and advised that court will be held in Linwood now. He thanked members of Northfield and Councilman Matik for completing the agreement.
