#### Reason for Change Order:

Change Order No. 1 - Final addresses the adjusted contract quantities for the completion of the 2022 Road Program, and addresses the addition of Supplemental Items S1 and S2.

Supplemental Item S1: Reconstruct Type "B" Inlet was added to the contract at the request of Linwood Public Works to reconstruct two existing Type 'B' Inlets that were damaged and missing masonry. One of the inlets was on Wabash Avenue and the other was on Seaview Avenue. The contractor cleaned, reconstructed, and parged the inlets, reset the existing castings, and repaired the pavement surrounding the inlets.

Supplemental Item S2: Country Club Drive Sinkhole Repair was added to the contract to investigate and repair a sinkhole in Country Club Drive prior to final paving. The contractor performed investigative test pits, removed loose brick from an old manhole structure that was buried beneath the roadway, and restored the roadway using DGA and HMA Base Course.
