VERIFIED PETITION

Petitioner BERLIN ROAD INVESTMENTS, LLC ("Licensee"), holder of Linwood (Atlantic County) Plenary Retail Consumption License № 0114-33-001-003, by way of petition to the Director of the Division of Alcoholic Beverage Control for a Special Ruling pursuant to N.J.S.A. 33:1-12.39, to allow the local issuing authority to consider its renewal application for the 2016-2017 and 2017-2018 license terms, states:

- 1. This license is the only license issued by the City of Linwood. It was initially purchased in 2004 from the City of Linwood as a "new" license for one-half million dollars, after a public referendum, for use in a specific restaurant within the Cornerstone Commerce Complex. It was purchased by an affiliate of the developer of the Cornerstone Commerce Complex in an effort to help develop the project.
 - 2. The license is a pocket license which has not been used since July 13,

2008, when the restaurant to which it was sited closed due to a partnership dispute. After the restaurant closed, the premises was converted to a different use and occupied by the operator of a kidney dialysis facility. That location is still used as a kidney dialysis facility.

- 3. Application to renew the license for the 2016-2017 license term was timely made and all fees were timely paid to both the State ABC and the City of Linwood.
- 4. This is the third petition for a "special ruling" filed by the Licensee. The first petition (dated June 15, 2011) sought a three year ruling (for license terms 2011-2012, 2012-2013 and 2013-2014. That petition was granted by Director Fischer by a Special Ruling dated September 19, 2011 under Docket № 07-11-7116. The second petition (dated July 16, 2014) sought a two year ruling (for license terms 2014-2015 and 2015-2016). That petition was granted by Director Halfacre by a Special Ruling dated September 8, 2014 under Docket № 07-14-8830.
- 5. The two earlier petitions are incorporated herein by reference. In summary, the first petition stated that there was no location in the entire City of Linwood to which the license could be sited, as a result of technical requirements in the Linwood liquor license ordinance concerning the size, location, configuration, zoning and other attributes of a licensed premises. The only premises that could be licensed was the former licensed premises, which was then (and still is) a kidney dialysis facility. In 2012, to make it possible to use the license at *some* location, the Licensee and the Linwood City Council worked together to revise the ordinance and remove many of the technical conditions concerning licensed premises. A revised

ordinance was adopted and became effective on or about September 17, 2012. As a result, the potential locations to which the license could be sited was significantly expanded.

- The second petition observed that since the ordinance amendment in September 2012, the Licensee sought to place this license into some revenue-generating productive use. In 2013 the Licensee explored a potential joint venture with an existing restaurant operator in the Cornerstone Commerce Complex. After many months of negotiations, the parties were unable to consummate a deal. At or about the same time, An affiliate of the licensee explored with the City of Linwood amending an existing redevelopment plan applicable to the Cornerstone Commerce Center and its surrounding campus, but it has not yet lead to the hoped-for development.
- 7. Development of the site has not occurred. As a result of the Southern New Jersey economy in general, and the Atlantic County economy in particular, there has been no significant interest expressed by third parties in developing the site or occupying any buildings that might be constructed at the site as part of a redevelopment plan.
- 8. There appears to be little or no demand for a liquor license in Linwood. In December 2014, the City put out for bid a second consumption license, with a minimum bid of \$300,000. This was a sharp decline in price from the \$500,000 previously paid by Berlin Road when it purchased its license "new" from the City. There were no bidders. In March of 2015, a new consumption license was again put out to bid, with a minimum bid of \$250,000. No bids were received. In August of

2015, a new consumption license was put out to bid by the City, with a minimum bid of \$212,500. Once again, no bids were received. A new consumption license was put out for bid by the City a fourth time, in September 2016. Bids are not due until October 27, 2016 and no bids have thus far been submitted,

- 9. In May of 2011, Bancorp Bank made loans to the licensee and its parent company and affiliates. Among the collateral provided for the loans was the entire membership interest in Berlin Road Investments, LLC, and developable land adjacent to the building to which the license was sited (and where it was used) when it was first issued to Berlin Road Investments by the City of Linwood. Bancorp assigned the loans to Walnut Street 2014-1 Issuer ("Walnut Street"). WS NEW STREET, LLC is a wholly owned subsidiary of Walnut Street.
- 10. The loans are presently in default. As part of a settlement concerning the loans, Walnut Street and its subsidiary WS NEW STREET have entered into agreements with the licensee and its parent company and affiliates. The agreement between the licensee and WS NEW STREET, LLC provides that WS NEW STREET will acquire the Linwood liquor license from Berlin Road Investments, LLC. (If the Director requests a copy of the agreement as an investigative record pursuant to N.J.A.C. 13:2-29.2 such that it will remain confidential, a copy will be submitted.) That portion of the settlement cannot be consummated until the license is transferred, and the license cannot be transferred until it is first renewed. The license cannot be renewed until a "special ruling" authorizing renewal is granted.
- 11. WS NEW STREET is in the business of short term real estate development. Walnut Street, the sole member of WS new Street, is a passive Wall Street investment company. Neither is in the business of operating food and

beverage establishments and neither will not conduct alcoholic beverage operations

under the authority of the license. The license is being acquired as part of a loan

settlement with the goal of selling it to a third party.

12. The License in its inactive state is a wholly unproductive asset. Upon

acquiring the licensee, WS NEW STREET, LLC will be most anxious to find a buyer

for the license so it can obtain a return on its investment.

Good cause exists to issue a "special ruling" pursuant to N.J.S.A. 33:1-13.

WHEREFORE, BERLIN ROAD INVESTMENTS, LLC respectfully requests

that the Director of the Division of Alcoholic Beverage Control issue a Special Ruling

THIS MATTER having initially come before the Court on September 10, 2015 for an on-the-record Case Management Conference; and thereafter this Court having appointed the Honorable Steven P. Perskie, J.S.C. (Ret'd.) to serve as Special Master, together with Richard B. Reading to serve as Special Regional Master; and the Court having conducted several separate case management conferences and conducted hearings with regard to Hamilton Township and Egg Harbor Township; and the Court believing it would be inequitable to impose any further assessment upon the City of Brigantine, the Township of Mullica, Hamilton Township and Egg Harbor Township; and the New Jersey Supreme

Court having made a ruling and issued an Order which this Court is hopeful will facilitate the settlement of most, if not all, of the above-captioned matters; and the Court being hopeful that this will be the final assessment to be made in this litigation; and all terms and conditions of the Court's Initial Case Management Order of September 28, 2015, being incorporated herein;

IT IS ON THIS 2/2 day of May, 2017, ORDERED, as follows:

1. Each of the municipalities remaining in "Category A", "Category B" and Category

- 1. Each of the municipalities remaining in "Category A", "Category B" and Category C" in Exhibit A shall, within sixty (60) days hereof, deposit into escrow the sum of \$1,000.00 with the "Fitzgerald & McGroarty, Mt. Laurel Litigation Escrow Account."
- 2. Any and all disbursements of the funds paid into escrow shall be pursuant to this Court's Order(s) and shall be limited to the fees and expenses of the professionals to be appointed hereunder.
- 3. Any future assessments of the Plaintiff municipalities shall be made in an effort to equitably assign the financial burden, based upon population and resources devoted to concluding such municipalities' DJ action.

IT IS FURTHER ORDERED that a copy of this Order shall be served upon all parties within seven (7) days of its receipt.
